SUSTAINABILITY UPDATE



SHE's Energy to Care Dashboard Tool offers an at-a-glance view of health care facilities' energy use. Designed to reduce user burden, the Energy to Care dashboard is easy to use. There's a misconception that sustainability programs and energy management are time-consuming, but they don't have to be. Sometimes the biggest impact on energy savings is made with simple changes. With the Energy to Care Dashboard's benchmarks and monitoring, it only takes 15 minutes a day to impact around half of your facility's budget.

The most recent updates and additions to the dashboard include an Environmental Widget that displays the equivalent carbon dioxide (CO2) emissions reduction-based energy consumption across all fuel types. This widget compares (CO2) emissions for the current year-to-date vs. the previous year-to-date by converting the building's total energy consumption to the equivalent tons of CO2 abated, the number of trees required for carbon sequestration, and the number of equivalent vehicles removed from the road. It's a great feature that helps healthcare facilities manage their decarbonization goals.

The data is weather-normalized or source-adjusted data and uses standard CO2 conversion factors. This widget is not controlled by the date selector tool, so it always provides a comparison of the current year-to-date emissions and the previous year's equivalent months.

A second new widget features the ASHE Energy to CareRegional Averages for the calendar year 2019. Energy is reported using each facility's Energy Use Index (EUI), measured in kBtu per square foot. This map shows the ASHE Regions and the average EUI for the ASHE facilities in each Region. The Average EUIs were calculated using data from the 2019 calendar year. Only sites with EUIs between 100 and 1000 kBtu per square foot were included in the average calculations. The map offers peer-to-peer benchmarking comparison so that healthcare facilities can measure their EUI performance against local (regional) facilities with similar climate conditions.

ADVOCACY UPDATE

Water Management Programs

s of January 1, 2022, The Joint Commission is enforcing their new Environment of Care Standard, EC.02.05.02, that mandates healthcare facilities to implement and maintain a Water Management Program to control Legionella bacteria and other waterborne pathogens. Within this standard, Element of Performance (EP) 2 requires the individual or team responsible for the Water Management Program to develop a basic diagram that maps all water supply sources, treatment systems, processing steps, control measures, and all end-use points. The diagram can be consolidated into a single page and consist of a simple, 1-line diagram format with the basic required information notated on it. The Joint Commission recommends referencing the CDC Toolkit: Developing a Water Management Program to Reduce Legionella Growth and Spread in Buildings, page 10. when developing this diagram.

Workplace Violence Prevention Programs

The Joint Commission has also communicated that they will verify workplace violence mitigation plans and measures during current and future accreditation surveys. The Joint Commission Standard HR.01.05.03 requires healthcare facilities to establish a workplace violence prevention program through documented training, education, and resources that define workplace violence incidents and roles and responsibilities of the internal and external response team. This standard also requires hospital staff to participate in training that covers de-esclation procedures, nonphysical intervention skills, physical intervention techniques, and the incident reporting process. Standadrd LD.03.01.01 requires healthcare facilities to establish policies and procedures specific to their workplace violence prevention program.
